# **PAYMENTS & DEPOSITS**

- Payment upon booking: non-refundable deposit, airfare (if applicable), rental car (if applicable) and travel insurance (if applicable) *This portion is non-refundable and non-transferrable.*
- Balance payment: due 45 days prior to program start date. EURO conversions to USD or CAD to be applied at time of payment at current retail exchange rates as per our foreign exchange broker – TD Foreign Exchange.
- Programs/services confirmed within 45 days of start date require full payment immediately.
- Tour documents will be delivered electronically approximately 2 to 3 weeks prior to your departure.

# CANCELLATION AND REFUND

#### Deposits, Airfares and Travel Insurance are 100% non-refundable and non-transferrable.

In the event of cancellations, the following charges will apply:

- More than 45 days prior to tour start date: deposit, airfares & travel insurance for land package
- From 45 to 22 days prior to tour start date:
- **50%** of the cost of the land package
- From 21 to 15 days of tour start date:
- 75% of the cost of the land package
- From 14 days to the day of the tour start date: 100% of the cost of the land package NO REFUND
- No refund will be made for unused portions of the trip.

### All cancellations must be made in writing. We strongly recommend cancellation insurance.
